Advanced training: regionalized modelling, Product Environmental Footprints (PEFs) and social LCA in openLCA

21th of September 2018

This training addresses advanced aspects of openLCA.

Specifically,

- Users can apply high-resolution regionalized inventories in openLCA and link them to regionalized LCIA models. As an example, the AWARE water footprint method is used in the training to create specific results for various regional resolutions.
- openLCA is core software for reading and exporting PEF pilot models and has implemented the new eILCD format for exchanging PEF models. openLCA has also own advanced format to exchange full models and contains the full PEF background database.
- Not the least, openLCA features unique possibilities to model social aspects for life cycle studies which will be addressed in the training

If you cancel your registration two weeks before the training you will be refunded the full amount of the training fee. If you cancel your registration 8 - 13 days before the training, you will be compensated for 50% of the training fee. If you cancel within one week before the training you will be billed the entire training fee. If you are unable to attend the training for any reason, it is possible to send a different person in your place.

The workshop will take place at GreenDelta's premises in Berlin.


